#### **NEW BUSINESS:**

- 2020 BOARD OF DIRECTORS ELECTION: The 2020 SSSA Board of Directors election will be held at the end of October / beginning of November 2019.
- 2020 ROBSON RANCH TOURNAMENT: Robson Ranch has invited the Saddlebrooke softball league to participate in a tournament to be held In January / February of 2020. A \$ 150. entry fee is required, which, will be paid by SSSA. Plans will be finalized at a later date.
