-**Congratulations to Barry Emmons** – Barry won the election for the Director's seat vacated by John Sentowski's resignation.

-Review March's Minutes - accepted

-Review March 14 Treasurer's Report – accepted

-Sponsorship Program – Paul Auster showed the new certificates that will replace the plaques that we've given in the past. Many of the sponsors were happy to see the certificates because of their appealing appearance, while some wanted to keep the plaques. The certificates are far more cost-effective in that they cost about \$3, compared to \$40 per plaque plus another \$9 annually for the update. Paul and Phil expect to complete the exchange with all the sponsors by the end of May. Six sponsor banners will be replaced at the SSSA expense (within budget). Andy M. and his wife's banners will be replaced at their cost. Some of the plywood that the banners are mounted on need to be replaced. Barry will determine which ones need to be replaced (within budget).

-HOA Employee Tournament – Peter reported that they will have 3 teams this year, HOA1, HOA2, and a team from The Highlands At Dove Mountain. They will seed the teams and play one game between the #2 and #3 seeds, and the winner will play the #1 seed (last year's champion) on Saturday, June 3.
